Renters understand, and shall ensure that their guests and invitees understand, that there likely are to be other renters or users on or near the Park facilities. Park users should understand that there are inherent risks in using or being present in the Park, including but not limited to the risk of property damage or personal injury caused by users of the pool, nearby baseball fields, or other pavilions. Use of the Park and its facilities is subject to an assumption of those risks."
