Dear Lucas:

As you know, we previously discussed the goal by Township staff to revise the existing Municipal Stormwater Maintenance Fund, in order to give it a new name and slightly broader purpose. As I understand it, the existing Fund is used solely to receive money from developers who are required to deposit money into that Fund when developing properly owned stormwater facilities pursuant to the Subdivision Ordinance. The Fund is then used for inspection and maintenance costs associated with those facilities. As I also understand it, however, you would like to propose that the Fund be used for all stormwater improvements, including activities relating to the MS4 requirements.

At your request, therefore, I have prepared the enclosed Resolution that can be considered by the Board. It is my understanding that this will be introduced to the Board at the August meeting, with an anticipated adoption at the September meeting. If there are any questions in the meantime, then, please feel free to let me know. Otherwise, as you can see, the Resolution does what I just described. It clarifies that the existing Municipal Stormwater Maintenance Fund will be renamed the "Stormwater Improvement Fund." The Resolution also clarifies the purposes for which the Fund is to be designated and used.

I trust this provides you with an update.
