The Blair Region Uniform Construction Code Board of Appeals is a citizen's commission authorized to review technically proficient challenges to the interpretations and decisions of the Code Officials of the Blair Region. The Board is authorized to grant administrative relief to claimants who prove that the true intent of the codes or the rules legally adopted there under have been incorrectly interpreted, the provisions of the codes do not fully apply, or an equally good or better form of construction can be used. This Board shall insure equitable and uniform code administration throughout the Boroughs of Bellwood, Duncansville, Hollidaysburg, Martinsburg and Tyrone and the Townships of Antis, Blair, Freedom, Greenfield, Logan, North Woodbury, Taylor and Tyrone.

Membership on the Board is open to all individuals qualified by training and experience as identified under Section 501 (c) of the Uniform Construction Code. Preference will be given to Blair Region residents. Please read the attached Joint Articles of Agreement before completing this application. Remember that the Code Committee will make their selection based upon objectively presented qualifications. The Committee welcomes any information in addition to what is required herein, which you believe to be pertinent.
